## Temporary Restrictions on the Import of Certain Products

DECEMBER 2025

## INTRODUCTION

The Government of Mozambique recently approved the adoption of temporary restrictions on the import of certain products. The products covered are identified in their own table, and economic agents are recommended to prioritize national production alternatives whenever available.

The following are the products subject to temporary import restrictions by category:

- Meat and edible meat offal of poultry
- Rice (not put up for retail sale)
- Sugar (not put up for retail sale)
- Refined Edible Palm Oil
- Bottled water and carbonated drinks
- Pasta
- Salt and sodium chloride
- Portland Cement
- Ceramic tiles
- Corn flour
- Alcoholic beverages (beer)
- Wooden and metal furniture
- Paper and Cardboard Products
- Non-alcoholic beverages and soft drinks
- Wheat grain
- Corn grain
